WHY I'M GIVING THIS PRESENTATION

- developed the Bud the Bunny iPad app (http://itunes.apple.com/us/app/bud-the-bunny/id524306896?mt=8)
- lots of info on eBooks, not so much on apps
- for the right property, app is a great way to engage audience
- want to share what I learned

iPAD vs. iPHONE vs. ANDROID

- this presentation is not about marketshare, value culture, distribution
- is about screen real estate and development tools

PS. From now on, "app" = "iPad app"

APP

- a lot or a little text
- a lot of images
- iPad, Android (operating systems/OS)
- can have audio
- can have video
- can have animation
- MUST HAVE INTERACTIVITY (reacts to user touch)

EBOOK

- mostly text
- can have images
- epub, mobi, pdf (file formats)
- can have audio
- can have video
- can have animation

Apps are software development. eBooks are translated into different file formats.

APP[LICATION] DEVELOPMENT (because apps are software)

- project management
- copy/text/words
- graphics/illustrations/photography
- animation
- audio
 - o voice over
 - sound effects
- coding/programming
- quality assurance (QA)/testing
- submission for distribution

APP CREATION OPTIONS

- 1. Someone Else = money
- 2. You = time
- 3. Combo = money & time

Assumption: you wrote the story and you want to develop an app

1. SOMEONE ELSE = MONEY

HAVE A SIGNED CONTRACT - no matter who the someone else is.

1.1 SOMEONE ELSE PAYMENT OPTIONS

- cashy money (\$3,000 \$10,000+)
- services exchange
- revenue share (App Store gets 30% first)
- combo of above

TANSTAAFL - there is no such thing as a free lunch*

*most of the time Clare Kramer (http://www.clarekrameronline.com/) is an exception - she recorded the voice over for the Bud the Bunny app and it only cost the studio time.

2. YOU = TIME

Be prepared to spend a lot of time.

Bud the Bunny took 333 hours over 95 days (avg. 3.5 hrs/day - in reality, 0 hrs some days and 9-11 hours other days)

2.1 3rd PARTY TOOLS/SOFTWARE/SERVICES

READ AND UNDERSTAND THE LEGAL STUFF

- "Terms & Conditions"
- "Digital Publishing Agreement"
- "Rights Usage"
- "Licensing"

One option I looked at had a contract where they would own all rights to anything uploaded through their service - so if I had used them, they would own everything about Bud the Bunny - from plays and plush toys to any other stories with that character. Not acceptable.

THIS IS YOUR INTELLECTUAL PROPERTY AND NO ONE CARES AS MUCH ABOUT IT AS YOU DO - READ AND UNDERSTAND THE LEGAL STUFF!

2.1.1 3rd PARTY TOOLS/SOFTWARE/SERVICES DUE DILLIGENCE

- who keeps what rights
- how is the revenue split (after the App Store takes 30%)
- cost
 - o upfront
 - o monthly fee
- available support
 - o tutorials (written user's guide, videos)
 - o forum
 - when was the last interaction
 - how many involved members
 - do questions get answered
 - any examples of finished projects using that tool/software/service

EX: uTales, Demibooks Composer (what I used to develop Bud the Bunny), Adobe, Filemaker, Quark, etc.

NOTE: anything that says it is an SDK (software development kit), such as Corona, is designed for programmers and you will have to learn and type in code.

I can code, I don't like to.

I wanted something to use that would do what I wanted without having to write code, which is why I chose Demibooks Composer (http://demibooks.com/composer/).

It uses pre-determined IF/THEN statements that are selected from a menu, so IF user touches this graphic, THEN do this action. You do not need to know anything about code to use Demibooks Composer, and they have a great support forum (one of the main reasons I chose them).

3. COMBO = MONEY & TIME

- Someone else does [X] and you HAVE A SIGNED CONTRACT
- You do [X] and you have READ AND UNDERSTAND THE LEGAL STUFF

EX: OCG Studios
